### **Bonamici, Merkley, Mannion, Underwood, Alsobrooks Launch Effort to Overturn Student Loan Rule**

Otherwise, the effects of this rule will be felt in communities across the country, especially in rural areas where nurse practitioners, midwives, and nurse anesthetists are often the only providers of core healthcare services."

By instituting lower federal student loan limits for social work students, the Trump Administration cut off the access that makes it possible to educate and prepare social workers who are the largest providers of mental health services in the nation.
