To address infrastructure needs for food banks serving rural communities and for other purposes.
1 Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,
3 SECTION 1. SHORT TITLE.
4 This Act may be cited as the "Supporting Transpor-

5 tation Organization and Refrigeration Expansion Act of

6 2025" or "STORE Act of 2025".

1	SEC. 2. IMPROVING THE EFAP INFRASTRUCTURE GRANTS
2	PROGRAM.
3	Section 209 of the Emergency Food Assistance Act
4	of 1983 (7 U.S.C. 7511a) is amended—
5	(1) in subsection (a) by striking "an emergency
6	feeding organization" and inserting "the State agen-
7	cy designated by a State in the State plan required
8	by section 202A (7 U.S.C. 7503)",
9	(2) in subsection $(b)(2)$ —
10	(A) by striking the heading and inserting
11	"Preference",
12	(B) by inserting "Tribal, low income, and
13	remote" before "communities", and
14	(C) in subparagraph (A) by striking and
15	inserting "rural" with "these",
16	(3) in subsection (c)—
17	(A) by striking "carry out activities of the
18	eligible entity" and inserting "distribute grant
19	amounts to support activities",
20	(B) in paragraph (1) by striking "for the
21	tracking of time-sensitive food products" and
22	inserting "needed to safely and efficiently dis-
23	tribute food to people in need",

12	SEC. 3. REPORT ON COLD STORAGE NEEDS NATIONALLY.
13	(a) Report.—Not later than 2 years after the date
14	of the enactment of this Act, the Secretary of Agriculture
15	shall carry out a study and produce a report—
16	(1) on the shortages to meet the total emer-
17	gency food needs for refrigerated and frozen storage
18	space, as well as refrigerated trucks and other deliv-
19	ery vehicles, for use by emergency food organizations
20	to meet the needs of their communities, and
21	(2) an estimate of the cost to meet the needs
22	of all emergency food organizations, including food
23	banks and food pantries, nationally for new coolers,
24	freezers, refrigerated and dry trucks, and trailers.
25	(b) Definitions.—In this section—

1	(1) Emergency food organization.—The
2	term "emergency food organization" has the mean-
3	ing given it in section 2 of the Emergency Food As-
4	sistance Act of 1983 (7 U.S.C. 7501) and is not oth-
5	erwise limited to relevant organizations participating
6	in the emergency food assistance program under
7	such Act.
8	(2) Shortages.—The term "shortages" means
9	meeting the total emergency food needs of the com-
10	munity, group, school, network, region, town, city,
11	state, or otherwise relevant area an emergency feed-
12	ing organization serves.
13	(c) APPROPRIATIONS.—There is appropriated, out of
14	any funds in the Treasury not otherwise appropriated,
15	\$1,000,000, to remain available until expended, to carry
16	out this section.
